The 2022 Anti-Corruption Forum addressed and discussed the practice of overseas bribery risk management.

In recent years, the U.S. FCPA (Foreign Corrupt Practices Act) has been actively enforced against companies operating around the world, including Japanese companies, and Japanese companies that have a nexus with U.S. may also be required to comply with the regulations. For this reason, in addition to domestic laws such as the Japanese Unfair Competition Prevention Law, it is useful for Japanese companies to consider risk-management measures in preparation for the enforcement of U.S. FCPA.

This Webinar invites [an U.S. attorney, Sam Amir Toossi \(Akrivis Law Group Partner\)](#), who has experiences as a former U.S. federal prosecutor and is specialized in white collar defense and regulatory compliance, to speak on compliance, extraterritorial jurisdiction, and crisis-management practices, including investigative procedures and responses at the U.S. DOJ and SEC.
